Now the Vindhya Shiksha Samiti has established Sardar Patel University by the "The Madhya Pradesh Nizi Vishwavidyalaya (Sthapana Avam Sanchalan) Sansodhan Adhiniyam, 2018" passed by the Government of Madhya Pradesh. The Vindhya Shiksha Samiti College comes under the campus of Sardar Patel University.
